The cost of trade stand space is calculated on the frontage and depth of the site and applicants wishing to economise on the cost of their space should keep the frontage as low as possible in relation to the depth.

THE AREA RESERVED MUST ALLOW FOR GUY ROPES, STAYS, SUPPORTS AROUND THE EXHIBIT AND GRASS LAWN, IF ANY OF THESE ARE NECESSARY.

Where it is absolutely essential for the applicant's vehicle to be parked on or immediately adjacent to the stand, space for this should be booked, otherwise vehicles will have to be parked in the car park.

A ramp for off loading machinery is available on the Showground.

FIRE REGULATIONS

Regulations stipulate that there must be a fire extinguisher on each stand. All applicants to complete with details of fire equipment to be provided

CONDITIONS

1. No trade exhibitors' vehicles are allowed on the site, unless parked on the booked site area. The gates will be locked at 8.45am. Any vehicles not on their sites by 9.00am will be towed away and charged at a rate of £100 for recovery. Vehicles not on stand sites are to be parked in the public car park.
2. The Society, its Officers or Servants, shall not in any way be responsible for any accident, damage or loss, however caused that may occur to any person, article or equipment entered or exhibited. Each exhibitor shall be solely responsible for any loss, injury or damage to, or occasioned by any animal, article or equipment belonging to them or in their case, and it is a condition of entry that each exhibitor shall indemnify and hold harmless the Society, its Officers and Servants from and against all actions, suits, expenses and claims on account of, or in respect of any such damage or injury which may be so caused or occasioned. L.P.G./gas/electric - all exhibitors are to ensure that their appliances have been examined and tested by a competent person and labelled to indicate the examiner's name and the date of the examination. No use of any appliance not so treated will be allowed. All use of L.P.G. on the site to be in accord with HSE Guidance note CF6. (The storage and use of LPG on construction sites). **Generators** - The Society will allow the use of 5KW maximum single phase generators providing that notice is given to the Society. Power output to be obtained from colour coded BS4343 sockets mounted on the generator. The electrical contractors and their staff are required to inspect all generators to ensure that the generator frame is bonded to the metallic enclosures, cables from the generator are suitable, and the correct load equipments in a fit state and safe to operate. A charge will of £10 plus VAT will be made for this inspection.
3. Space can only be booked subject to being available. The Society reserves the right to refuse or cancel any booking, to locate position of space and if necessary, alter dimensions. Whilst every endeavour will be made to comply with the wishes of all exhibitors, the allotment must be accepted by the exhibitor. The decision of the Chief Steward at the Show is final and binding on all exhibitors.
4. Booked trade space will be marked by a suitably numbered peg, placed in the left hand front corner of the site, which must be left in position during the whole period of the Show. The space between front pegs and edge of road must be kept absolutely clear at all times.
5. No digging or removal of earth or turf to be made without prior consent. Any damage to be made good by the exhibitor.
6. Complimentary tickets will be issued as appropriate. Where a Head Office has not forwarded the tickets, staff will be charged and a refund will be made on the return of the free issues. Tradestand holders are requested to keep the number of vehicles entering the Showground during the Show to a minimum to avoid congestion.
7. Charges are for full periods of the Show. Trade exhibitors undertake to keep stands open for the day. NO PART OF THE EXHIBIT MAY BE DISMANTLED EARLIER THAN 5.00PM ON THE DAY OF THE SHOW. VEHICLES COLLECTING PARTS OF THE STAND WILL NOT BE ALLOWED TO ENTER THE SHOWGROUND UNTIL 5.00PM TO AVOID TRAFFIC CONGESTION.
8. Entry onto the ground for purposes of preparation can be arranged seven days before the date of the Show. All equipment must be removed and the site cleaned within four days following the Show.
9. Tradestand holders will be responsible for providing their own refuse bins which will be emptied by the Society.
10. Exhibitors are not permitted to sub-let any portion of their stand except to their local agent or distributor.
11. Exhibitors will be responsible for the safe working of all machinery in motion, which must be protected from the general public by means of a substantial protective guard.
12. NO RAFFLE TICKETS MAY BE SOLD ON THE SHOWGROUND EITHER OFF OR ON THE STANDS.
13. The Society reserve the right to refuse an application where the frontage asked for exceeds the depth by more than three metres.
14. Space will not be allocated until payment is received.
15. Trading must be carried on only as stated on the returned, except with the express permission of the Show Secretary.
16. TRADE STANDS NOT TAKEN UP BY 10.00AM WILL BE RE-LET IF THE SHOW OFFICE HAS NOT BEEN INFORMED OF THE REASON FOR DELAY.
17. No refunds for cancelled bookings after 1st September 2010.

NOTE: EXHIBITORS ARE REQUESTED TO NOTE THAT WHERE ANY EXCAVATIONS ARE INTENDED TO BE MADE ON THEIR SITE (INCLUDING DRIVING IN TENT PEGS, HOLE BORERS FOR FLAG POLES, ETC) NO SUCH WORK MAY BE UNDERTAKEN WITHOUT A CERTIFICATE OF AUTHORITY SIGNED BY A REPRESENTATIVE OF THE SOCIETY.
